Bidding is open to all eligible Nepalese
- The Kaligandaki Rural Muncipality invites electronic bids only from eligible bidders for Fabrication, Supply, Transportation, Construction and Erection of suspended Trail Bridge at Barichaur Mandrang Long Span Trail Bridges (LSTB) through Construction Turnkey Package (CTP). Qualification requirement: Average Annual Construction Turnover and Experience requirements are given below. Detailed Evaluation and Qualification Criteria are provided in Section 3 of the Bid Documents.

- Bids will be opened in the presence of Bidders' representatives who choose to attend on 14:00 Hrs of 30th Falgun 2076 (13th March 2020) at the office of Rural Municipal Executive, Kaligandaki Rural Municipality, Syangja. Bids must be valid for a period of 90 days after bid opening deadline and must be accompanied by a scanned copy of the bid security amounting as below in pdf format, which shall be valid for 30 days beyond the validity period of the bid. Bidder who choose to provide bid security in form of cash, the cash amount should be deposited in dharauti account of Kaligandaki Rural Municipality, Account No. 06700026CA at Prime Bank Ltd., Kaligandaki Branch.
