- The Government of Nepal (GON) and Kaligandaki Rural Municipality, Office of rural Municipal Executive
 has allocated funds towards the cost of CONSTRUCTION OF OFFICE BUILDING OF KALIGANDAKI
 RURAL MUNICIPALITY] and intends to apply part of the funds to cover eligible payments under the Contract
 for KLGD-W-NCB-OBKLRM-07-076-77. Bidding is open to all eligible as per Section V of bidding document.
- 2. Kaligandaki Rural Municipality, Office of the rural Municipal Executive invites electronic bids from eligible bidders for the CONSTRUCTION OF OFFICE BUILDING OF KALIGANDAKI RURAL MUNICIPALITY under National Competitive Bidding Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 130,000,000.00
 - Minimum Work experience of similar size and nature: Successfully or substantially completion of one number of RCC frame structured Building Project with the value of NRs. 90,000,000.00 excluding VAT.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed
 envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed
 envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Kaligandaki Rural Municipality, Office of the Rural Municipal Executive or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

Bidders, submitting their bid electronically, should deposit the cost of bidding document Rs 10,000.00 Rajaswa (revenue) account as specified below.

- Pre-bid meeting shall be held at Kaligandaki Rural Municipality, Office of the rural Municipal Executive, Syangja on 13:00
 Hrs of 7th Chaitra 2076 (20th March 2020)
- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hrs
 on 23rd Chaitra 2076 (5th April 2020). Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 23rd Chaitra 2076 (5th April 2020) at the office of Rural Municipal Executive, Kaligandaki Rural Municipality, Syangja.
- Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs 2,800,000.00, which shall be valid for 30 days beyond the validity period of the bid. Bidder who choose to provide bid security in form of cash, the cash amount should be deposited in dharauti account of Kaligandaki Rural Municipality, Account No. 06700026CA at Prime Bank Ltd., Kaligandaki Branch.
- 10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
